Vimla Nadkarni, Ph.D., M.S.W.

Dr. Nadkarni is an internationally and nationally known leader, scholar and educator in the field of international social work, social work education and practice.

Dr. Nadkarni was the former dean of the TISS School of Social Work and served as head of the Centre for Health and Mental Health for twenty years. She set up a National Network of Schools of Social Work in India and is a founding member of the International Social Work Network in Health Inequalities. Dr. Nadkarni was the 2nd Annual Hokenstad International Lecturer at the Council of Social Work Education Annual Conference and was a recipient of Fulbright and Kellogg Fellowships.

She is a leading expert in community health, health management, monitoring and evaluation, HIV/AIDS policy and interventions, reproductive health, health ethics and human rights, and ecology and health. She has published widely on health, mental health, ecology and HIV/AIDS in national and international journals/books. Her edited book titled "NGOs, Urban Health and the Poor" was published in 2009.
