Policy Practice is one of three specialized concentrations that Master of Social Work students can choose as their focus in the degree program. It prepares students to advocate in organizations and government to improve laws, regulations, and policies that affect vulnerable populations.

This method of social work practice leads to change in public and private institutions and systems to increase equity and improve people's lives. Policy practice activities include:

- Analyzing existing policies and crafting policy proposals
- Administering social programs
- Conducting needs and community assessments
- Using research and data in policymaking
- Writing grant proposals
- Implementing political strategies
- Writing legislative policy briefs

Who Should Consider Policy Practice?

Undergraduates in disciplines such as political science, public policy, sociology, urban studies, women's and gender studies, human rights, human development and family sciences, or cultural studies should consider an MSW with a Policy Practice concentration for their graduate degree.

Policy Practice students receive a strong foundation in social work and preparation for a professional practice degree in addition to skills that promote change in policy and political spaces. Students are taught by faculty who are renowned in their fields and have connections to innovative internships and job opportunities. At UConn School of Social Work, students also have opportunities to engage in political social work, international social work, and to pursue dual or joint degrees in law, public health, public administration, and divinity.
